DILLARD RECEIVES SERVICE AWARD

Regional Transportation Authority of Northeastern Illinois Chairman Kirk Dillard of Hinsdale has been chosen to receive a 2017 Local Distinguished Service Award by the American Public Transportation Association, an international association of 1,500 public and private sector organizations.

The APTA "best of the best" awards recognize excellence in the public transportation industry in North America on the individual and organizational level.

"I am pleased to offer my congratulations to Chairman Dillard," said RTA Executive Director Leanne Redden. "From the moment he was handed the gavel he has worked tirelessly in our region, in Springfield and in Washington D.C. to advocate for the needs of regional transit riders. In both his decades of experience in the state legislature and his work with the leadership of CTA, Metra and Pace, his focus is on collaboration over division and communication over discord. Our transit region is better for having his leadership.'

Dillard is a lifelong transit rider and regularly rides the RTA regional system to his offices in downtown Chicago, where he is a partner at Locke Lord LLP, one of Chicago's oldest and largest law firms.

Before becoming RTA chairman in 2014, Dillard served as the Republican senator for the 24th District of the Illinois Senate for almost 20 years. Prior to serving as state senator, Dillard served with distinction as chief of staff to former Governor Jim Edgar and as legislative director to former Governor James Thompson.

Dillard and the other award recipients will receive their awards at the APTA annual meeting/EXPO on Oct. 10 in Atlanta.

KROLL HELPS WIN HISTORIC VERDICT

Jeffrey Kroll of Hinsdale was on the team of attorneys that secured a \$148 million verdict from the city of Chicago for 24-year-old Tierney Darden in a personal injury case.

Darden was paralyzed when the pedestrian shelter she was standing next to outside of O'Hare International Airport collapsed onto her in 2015. The verdict represents a new Cook County personal injury record jury verdict.

The \$148 million verdict was obtained after a 10-day trial by Kroll and attorneys Patrick Salvi, Tara Devine, Patrick Salvi II and Eirene Salvi of the Illinois personal injury law firm Salvi, Schostok & Pritchard.

The prior highest Cook County personal jury verdict was \$127.7 million in 1991.
